ACT NO. 18-13

AN ACT

To appropriate the sum of \$90,944.00 from the General Fund of the State of Chuuk for the fiscal year ending September 30, 2026, for the purpose of funding the Northern Namoneas Special Election to fill a vacancy in the House of Representatives, to set conditions for the expenditures, to designate allottee of the funds, and for other purposes.

Be it enacted by the Chuuk State Legislature:

1 **Section 1. Purpose.** The Legislature finds that a vacancy currently exists in the House
2 of Representatives representing the Northern Namoneas region. To ensure that the people of
3 Northern Namoneas maintain their fundamental right to representation and a voice within the
4 Chuuk State Legislature, it is a matter of urgent public necessity that a Special Election be
5 conducted.

6 **Section 2. Appropriation.** The sum of \$90,944.00, or so much thereof as may be
7 necessary, is hereby appropriated from the General Fund of the State for the purpose of
8 funding the Northern Namoneas Special Election.

9 **Section 3. Allocation and Use of Funds.** The funds appropriated under Section 2 shall
10 be apportioned according to the following budgetary breakdown:

18 **Section 4. Condition for Expenditure.** Notwithstanding any other provision of law,
19 funds appropriated under this Act shall be obligated, encumbered, administer or disbursed,
20 pursuant to CSSC Civil Action NO. 034-2025.

21 **Section 5. Administration and Designation of Allottee.** The chairman of the holdover
22 board, or his authorized designee, shall be the allottee of these funds. The allottee shall be
23 responsible for ensuring that these funds are used solely for the purposes specified in this Act


1 and shall provide a full financial report to the Legislature within thirty (30) days of the
2 conclusion of the election.

3 **Section 6. Lapse.** These funds shall remain available until September 30, 2026.

4 **Section 7. Effective Date.** This Act shall take effect upon its approval by the Governor,
5 or upon its becoming law without such approval.




