ACT NO. 18-14

AN ACT

To reappropriate the lapsed sums of \$205,836.62 and \$14,031.50 from the General Fund of Chuuk State to satisfy the 8% revenue share requirements for Weno and Moch Municipalities for Fiscal Year 2025, and for other purposes.

Be it enacted by the Chuuk State Legislature:

1 **Section 1. Purpose.** The Chuuk State Legislature finds that the Weno and Moch
2 Municipalities did not receive their full 8% revenue share previously appropriated and
3 allocated to them for Fiscal Year 2025, as required by Section 6, Article VIII of the Chuuk
4 State Constitution. Specifically, Weno Municipality did not receive its full allocation, and
5 Moch Municipality did not receive its allocation for the final two quarters of Fiscal Year 2025.
6 This Act hereby appropriates the sum of \$205,838.62 and \$14,031.50 from the General Fund
7 for the eight (8%) percent share for the operation of the Weno Municipality and the Moch
8 Municipality, respectively, for Fiscal Year 2025.

9 **Section 2. Appropriation.** The sum of \$219,870.12, or so much thereof, is hereby
10 appropriated from the General Fund of Chuuk State for the purpose of restoring the lapsed
11 fiscal year 2025 8% revenue share as mandated by Section 6 Article VIII of the Chuuk State
12 Constitution for Weno Municipality and Moch Municipality as follows:


- 13 1. \$205,838.62 for the operation of the Weno Municipality; and
- 14 2. \$14,031.50 for the operation of the Moch Municipality.

15 The Governor shall be the allottee of the funds.


16 **Section 3. Expenditure.** For the proper allocation, distribution and safeguard, the
17 funds shall be expended in accordance with the Chuuk State Constitution, Financial
18 Management Act, as amended, its implementing Rules and Regulations any applicable
19 law.

20 **Section 4. Reporting.** The Governor through the Department of Administrative
21 Services shall submit a written report to the Chuuk State Legislature regarding the
22 disposition of the funds appropriated herein within six (6) months after the fund is fully
23 expended.


1 **Section 5. Effective Date.** This act shall take effect upon approval by the Governor or




