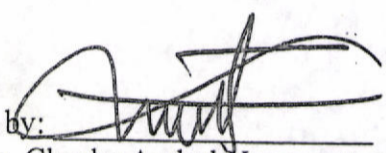
Confirming the nomination of Bryan Mori as the Special Assistant to the Governor on Social Affairs.
