

A JOINT RESOLUTION


Setting a time for recess and setting a date and time to reconvene to continue the First Regular Session of the Eighteenth Chuuk State Legislature.

1 **WHEREAS**, the Eighteenth Chuuk State Legislature has convened and organized
2 according to the laws of the State of Chuuk and the Rules of Procedure, of the House of
3 Representatives and the Senate, Seventeenth Chuuk State Legislature; and


4 **WHEREAS**, the Constitution of the State of Chuuk Article V Section 13 authorizes
5 the Legislature to adjourn for more than two consecutive days, provided such adjournment is
6 done with the concurrence of both Houses of the Legislature; now therefore

7 **BE IT RESOLVED**, by the Eighteenth Chuuk State Legislature that both Houses of
8 the Legislature shall go into recess on the 12th day of May 2025 and remain in recess until
9 the 28th day of July 2025, on which day the Chuuk State Legislature shall reconvene, at the
10 hour of 10:00 A.M.; now therefore


11 **BE IT FURTHER RESOLVED**, the certified copies of this Joint Resolution be
