

A JOINT RESOLUTION

Expressing the profound gratitude of the Eighteenth Chuuk State Legislature to the Pohnpei State Legislature and the State of Pohnpei for hosting the first ALL4US Meeting and for their leadership in establishing this historic forum for inter-state collaboration.

1 **WHEREAS**, recognizing the growing need for a collaborative platform, the Yap State
2 Legislature first proposed the establishment of a unified forum for the four state legislatures
3 of the Federated States of Micronesia (FSM) during the 61st Association of the Pacific Islands
4 Legislatures (APIL) Board of Directors Meeting in Yap in March 2024; and

5 **WHEREAS**, during the APIL 41st General Assembly in Palau in September, 2024,
6 the FSM state legislative delegations, under the leadership of the Pohnpei Legislature and the
7 Honorable Speaker Marvin Yamaguchi, met and collectively affirmed the importance of
8 creating a dedicated space to discuss shared challenges, including issues related to Compact
9 sector grant distribution and fishing fees; and

10 **WHEREAS**, the establishment of ALL4US provides a vital platform to strengthen the
11 collaboration and align the efforts of the four states of the FSM—Pohnpei, Yap, Chuuk, and
12 Kosrae—by serving as a dedicated forum to discuss common goals, objectives, and shared
13 concerns for the betterment of the people of the FSM; and

14 **WHEREAS**, the Pohnpei Legislature's legal team demonstrated outstanding initiative
15 and collaboration by drafting the foundational charter for ALL4US, which was subsequently
16 endorsed by all four FSM state legislatures; and

17 **WHEREAS**, the State of Pohnpei and the Pohnpei Legislature is gracious to host the
18 inaugural ALL4US Meeting, providing a welcoming venue and invaluable support that
19 ensured the meeting's success and cemented this new era of cooperation; and


20 **WHEREAS**, the hospitality, logistical support, and dedicated leadership
21 demonstrated by the Pohnpei Legislature and the State of Pohnpei is instrumental in bringing
22 the ALL4US concept to fruition and establishing a strong foundation for its future success;

25 Senate, Eighteenth Chuuk State Legislature, First Regular Session, April 2025 that the Chuuk
