**A JOINT RESOLUTION**

Calling both Houses of the Eighteenth Chuuk State Legislature, First Regular Session, April, 2025 to adjourn sine die on Monday, October 27, 2025.


1           **WHEREAS**, the Eighteenth Chuuk State Legislature has convened and organized  
2 according to the laws of the State of Chuuk and the Rules of Procedure of the House of  
3 Representatives and the Senate; and

4           **WHEREAS**, Article V Section 13 of the Chuuk State Constitution provides that  
5 neither house may adjourn for more than 2 consecutive days nor may either house adjourn  
6 sine die without the concurrence of the other house; now therefore


7           **BE IT RESOLVED** by the House of Representatives, Eighteenth Chuuk State  
8 Legislature, First Regular Session, April, 2025 with the concurrence of the Senate, that both  
9 houses of the Eighteenth Chuuk State Legislature shall adjourn sine die on October 27, 2025;

12 transmitted to the Governor of the State of Chuuk, the Chief Justice of the Chuuk State
