A RESOLUTION

Requesting the Government of the People’s Republic of China to provide the financial and technical assistance for the upgrading and construction of the road network on Tonoas Island, Chuuk State.

1 **WHEREAS**, the House of Representatives recognizes and values the deep and
2 enduring diplomatic relations, mutual respect, and fruitful economic cooperation that exist
3 between the Federated States of Micronesia and the People’s Republic of China; and

4 **WHEREAS**, the Government of the People’s Republic of China has consistently
5 demonstrated its commitment to global development, particularly in supporting infrastructure
6 and sustainable growth within Pacific Island nations; and

7 **WHEREAS**, the inhabitants of Tonoas Island face significant challenges due to the
8 current condition of the internal road network, which severely impedes safe transportation,
9 connectivity, and timely access to vital services, including healthcare and education; and

10 **WHEREAS**, Tonoas Island has recently achieved a major milestone in its
11 infrastructure development, with approximately three hundred (300) households now
12 connected to the Chuuk State Public Utility Power Grid, making the development of reliable
13 access roads critical to ensure that this new energy access can translate into broader
14 commercial, social, and technological advancement; and

15 **WHEREAS**, the proposed Tonoas Island Road Network Project is essential to
16 unlocking the island’s economic potential, facilitating agricultural and commercial activity,
17 and markedly improving the overall quality of life and public safety for its residents; and

18 **WHEREAS**, the successful completion of this vital infrastructure project aligns with
19 the principles of partnership and shared prosperity that form the foundation of the bilateral
20 relationship; now, therefore,

21 **BE IT RESOLVED** by the House of Representative, Eighteenth Chuuk State
22 Legislature, First Regular Session, Second Special Session, November, 2025 that it hereby
23 formally and respectfully requests the Government of the People’s Republic of China, through
24 its relevant foreign aid and development agencies, to provide financial, technical, and material

1 assistance necessary for the immediate planning, engineering, and construction phases of the
2 Tonoas Island Road Network Project; and

3 **BE IT FURTHER RESOLVED** that certified copies of this resolution be transmitted
4 to the Ambassador of the People's Republic of China to the Federated States of Micronesia,
5 and through appropriate diplomatic channels, to the Ministry of Foreign Affairs of the
6 People's Republic of China, to the Secretary of the FSM Department of Foreign Affairs, to
7 the Governor of the State of Chuuk, to the President of the Senate, and to the Chief Justice of
8 the Chuuk State Supreme Court.




