**A HOUSE JOINT RESOLUTION**

Calling both Houses of the Eighteenth Chuuk State Legislature, First Regular Session, April, 2025 to adjourn sine die on Monday, October 27, 2025.


1           **WHEREAS**, the Eighteenth Chuuk State Legislature has convened and organized  
2 according to the laws of the State of Chuuk and the Rules of Procedure of the House of  
3 Representatives and the Senate; and

4           **WHEREAS**, Article V Section 13 of the Chuuk State Constitution provides that  
5 neither house may adjourn for more than 2 consecutive days nor may either house adjourn  
6 sine die without the concurrence of the other house; now therefore

7           **BE IT RESOLVED** by the House of Representatives, Eighteenth Chuuk State Legislature,  
8 First Regular Session, April, 2025 with the concurrence of the Senate, that both houses of  
9 the Eighteenth Chuuk State Legislature shall adjourn sine die on October 27, 2025; and

10           **BE IT FURTHER RESOLVED** that certified copies of this Joint Resolution be  
11 transmitted to the Governor of the State of Chuuk, the Chief Justice of the Chuuk State  
12 Supreme Court and the Chairman of the Council of Mayors.
