Re: Act 18-08

Dear President Kony and Speaker Mersai:

After carefully reviewing the recently passed Debt Relief Act 18-08 appropriating Two Million Seven Hundred Thousand Dollars (US \$2.7 million), by designating it as CSL 18-25-08, and upon receiving the legal opinion of the Attorney General's Office, I hereby approve the Act, but with great reservation.

My concern arises from the attachment of a detailed list of individual payees and fixed payment amounts, which raises significant constitutional and statutory issues. As explained by the Attorney General's Office, such an attachment appears to direct the execution and administration of the appropriation functions that the Constitution vests exclusively in the Executive Branch. While the Legislature possesses authority to appropriate funds, the execution, prioritization, and administration of payments fall solely under the Debt Relief Taskforce and the Department of Administrative Services as established by CSL 9-07-09 and CSL 15-19-06 as amended.

The legal opinion further highlights that the current statutory structure governing the Debt Relief Fund requires refinement to avoid future conflicts between legislative appropriations and executive implementation. In accordance with this guidance, I will be seeking amendments to CSL 15-19-06 to ensure that the law clearly aligns with the constitutional separation of powers and the legal requirements governing verification, prioritization, and disbursement of State debts.

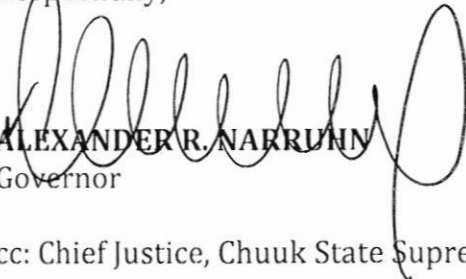
My approval of Act 18-08 should therefore be understood as limited and conditioned upon the need to correct these underlying statutory deficiencies. The Executive Branch will proceed with implementing the appropriation strictly in accordance with existing law and

the proper functions of the Debt Relief Taskforce, while simultaneously initiating the legislative amendments necessary to resolve the issues identified by the Attorney General' Office.

I look forward to working collaboratively with the Legislature to strengthen the legal framework governing the Debt Relief Fund and to ensure that future appropriations are administered with transparency, consistency, and full constitutional compliance.

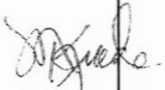

ACT NO. 18-08

AN ACT

To appropriate Two Million, Five Hundred Thousand Dollars (\$2,500,000.00) from the General Fund sourced from the Fishing Fees and the sum of \$227,727.09 sourced from the Debt Relief Fund for the purpose of paying the debts and obligations of Chuuk State Government pursuant to CSL No. 9-07-09, as amended by CSL No. 15-19-06, to impose restrictions and limitations, and for other purposes.

Be it enacted by the Chuuk State Legislature:

1 **Section 1. Appropriation.** The sum of Two Million, Five Hundred Thousand Dollars
2 (\$2,500,000.00) source from the Fishing Fees and the sum of \$227,727.09 sourced from the
3 Debt Relief Fund for the purpose of paying the debts and obligations Chuuk State Government
4 from creditors pursuant to CSL 9-07-09, as amended by CSL 15-19-06.

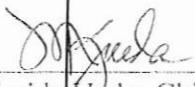
5 **Section 2. Restrictions and Limitations.** The Task Force created under CSL No. 9-
6 07-09, as amended by CSL No. 15-19-06, shall solely expend any and all amounts
7 appropriated herein in accordance with this Act, CSL No. 9-07-09, as amended by CSL No.
8 15-19-06, the Financial Management Act of the State, and its implementing rules and
9 regulations and other relevant laws. Furthermore, the funds appropriated in Section 1 shall
10 only be applied to principal balances of debts owed by the Chuuk State Government pursuant
11 to Section 7 (5) of Chuuk State Law No. 8-05-12 as amended. These funds shall remain
12 available until fully expended. The Governor shall be the allottee of this fund and all payments
13 under this Act shall be made by the Joint Government Restructuring Taskforce.

14 **Section 3. Report.** The Director of Administrative Services of Chuuk State
15 Government and the Joint Government Restructuring Taskforce shall file and submit reports
16 to the Governor and the Chuuk State Legislature within 30 days after the full expenditure is
17 made.

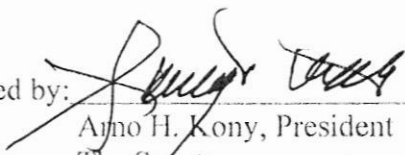
18 **Section 4. Effective Date.** This Act shall take effect upon approval by the Governor,
19 or upon its becoming law without such approval.
