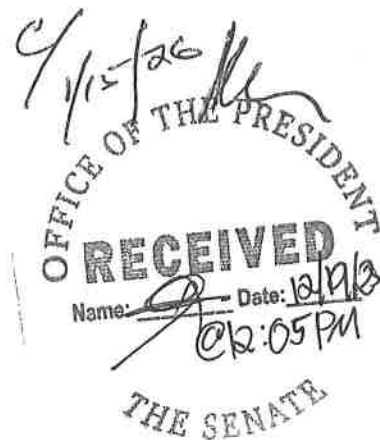

CHUUK STATE LAW NO. 18-25-11

ACT NO. 18-11

AN ACT

To appropriate the sum of \$406,790.00 or so much thereof for the purpose of acquiring private land for the future site of the new Chuuk State Hospital, and for other purposes.

Be it enacted by the Chuuk State Legislature:

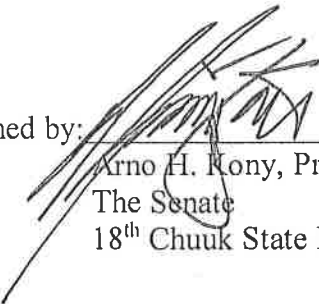
1           **Section 1. Purpose.** It seems to be a never-ending land issue for the site of our only  
2 Chuuk State Hospital and maybe some other land occupied any government departments,  
3 offices or agencies. For us Chuukese, land is the most valuable that we inherited from our  
4 ancestors and considering the scarcity of lands in Chuuk State. While Chuuk State  
5 Government has an inherit authority by law to obtain or take lands for public purpose, this  
6 authority was rarely exercised due to unavailability of funds and Chuukese customary value  
7 to hold dear on to their land, sometimes at whatever cost, due to the foreign concept or nature  
8 of government acquiring private lands intended for public purpose. However, due to the  
9 financial windfall of additional revenue as a result of the fifty (50%) percent share of the State  
10 from fishing fees, Chuuk State can now afford to acquire private lands for public purpose. As  
11 a result of this, the Leaders of Chuuk State during the Leadership Conference last November  
12 2024 passed a resolution, among others, to appropriate an amount of Two Million Five  
13 Hundred Thousand Dollars (\$2,500,000.00) annually to obtain private lands for public  
14 purpose.

15           **Section 2. Appropriation.** The sum of Four Hundred Six Thousand Seven Hundred  
16 Ninety Dollars (\$406,790.00) or so much thereof is hereby authorized and appropriated for  
17 the purpose of acquiring private real property as part of the future site of the new Chuuk State  
18 Hospital which will be sourced from the available local revenue fund.

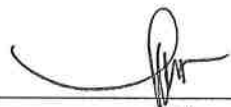
19           **Section 3. Restrictions and Limitations.** The amount appropriated herein shall be  
20 solely expended in accordance with CSL No. 10-10-18, as amended by CSL No. 10-10-37  
21 and Executive Orders regarding land valuation, the Financial Management Act of the State,  
22 and its implementing rules and regulations and other relevant laws. These funds shall remain  
23 available until fully expended. The Governor shall be the allottee of this fund and all payments  
24 under this Act shall be made by the Director of DAS.

1           **Section 4. Report.** The Director of Administrative Services of Chuuk State  
2 Government and the Attorney General’s Office shall file and submit reports to the Governor  
3 and the Chuuk State Legislature within 30 days after the full expenditure is made.

4           **Section 5. Effective Date.** This Act shall take effect upon approval by the Governor,  
5 or upon its becoming law without such approval.
